Membership Termination Clause:

 - Violate the Foundation's MOA, rules, and regulations.
 - Engage in activities that harm the reputation or objectives of the Foundation.
 - Fail to fulfil their responsibilities for an extended period.
 - Breach confidentiality or ethical standards.
 - **Notice of Termination:** Members will be given a 14-day notice period to address issues before termination.
 - **No Refunds:** Membership fees are non-refundable upon termination.
 - **Re-application:** Terminated members may reapply after a 6-month period, subject to approval by the governing committee.
